

# 税务信息 1099G 表格

## 什么是1099G 表格？

1099G 表格是加利福尼亚州就业发展部 (Employment Development Department, EDD) 在一个历年内向您出具的应纳税总收入的记录。该表格会报至 IRS。

如果您从 EDD 领取失业救济金，您将收到 1099G 表格，并且必须将该救济金作为收入在您的联邦报税表中申报。该笔收入免征加利福尼亚州所得税。

应纳税失业救济金包括：

- 失业保险 (Unemployment Insurance, UI) 福利，包括：
  - 联邦延长救济 (Federal Extensions, FED-ED)
  - 工资损失援助 (Lost Wages Assistance, LWA)
  - 大流行额外救济金 (Pandemic Additional Compensation, PAC)
  - 大流行紧急失业救济金 (Pandemic Emergency Unemployment Compensation, PEUC)
  - 混合收入者失业救济金 (Mixed Earner Unemployment Compensation, MEUC)
- 大流行失业补助 (Pandemic Unemployment Assistance, PUA) 福利
- 作为失业保险 (UI) 福利的替代品而获得的残障保险 (Disability Insurance, DI) 福利
- 灾难失业援助 (Disaster Unemployment Assistance, DUA) 福利
- 带薪家庭假 (Paid Family Leave, PFL) 福利

## 何时能获得1099G 表格？

我们会在2022年1月31日之前向您提供2021年的1099G表格。我们会将表格邮寄给您，除非您在2021年12月27日之前选择拒收纸质副本。如需选择拒收纸质副本，请在 [UI Online](#) 中选择 **Profile**，并更新您的 **Form 1099G Preferences** 信息。

如果出现以下情况，请致电1-866-401-2849：

- 在表格上看到\$0的金额。
- 您更换了邮寄地址。您也可以在 [UI Online](#) 账户中更改您的联系信息，或用正确信息创建账户。
- 如果您的1099G表格有任何调整，则该表格将不会在线显示。

## 如何索取我的1099G表格副本？

1099G表格税务信息最长可在五年内在 [UI Online](#) 获取。若要在线访问副本或索取纸质副本，请执行以下操作：

1. 登录 [Benefit Programs Online](#)。
2. 选择 **UI Online**。
3. 选择 **Form 1099G** > View 选择需要查看的年份 > Print 或 Request Paper Copy。

The federal EITC is a refundable federal income tax credit available to low to moderate income working individuals and families. The EITC has no effect on eligibility for Medicaid, Supplemental Security Income, food stamps, or most other temporary assistance for those in need. Even if you do not owe federal taxes, you must file a tax return to receive the EITC.
